


# **PuraEarth Testing Labels**

The AZDHS (AZ Dept. of Health) requires all cannabis products to be tested for THC and CBD along with Solvents, Heavy Metals, Pesticides, and Microbials. At PuraEarth, knowing just what the THC and CBD Concentrations are is simply not enough. Our products contain a full spectrum of cannabinoids that together, provides you with a full entourage effect you feel from using our products.

As a result, every one of our products features a QR Code that directs you to the actual full-panel test results as well as on the label itself, a full list of every cannabinoid found in this product, not just THC and CBD.

# **PuraEarth Tests Every Product Twice**

Every PuraEarth product is tested twice. We begin by testing the batch of Cannabis Oil used in this product prior to the reintroduction of any terpenes. We call this the "Master Oil Batch." Once we know the "Master Oil Batch" passes our internal QA/QC metrics and is AZDHS Compliant, we then introduce our strain-specific terpenes and test the oil batch again. We call this the "Strain Batch." Once the "Strain Batch" is processed and made into cartridges, syringes, etc, we track every batch of product made. This is called the "Product Batch."

# The Test Results within this Document

Within this document, you will find 2 test results attached: 1) The test results from the "Master Oil Batch" and 2) the test results from the "Strain Batch." Each of these have 4-digit batch numbers that you can use to verify the legitimacy of this product.

# Matching Test Results with Testing Labels

To ensure the test results you see from scanning the QR Code match the product you purchased, simply match the 4-digit "Master Oil Batch" number and the 4-digit "Strain Batch" number found on the Test Results within this document with the 4-digit batch numbers printed onto the Testing Label adhered to the product you purchased.

Master Oil Batch = Starting Cannabis Oil Used in this Product Strain Batch = Cannabis Oil Used After Terpenes are Reintroduced
